PPE Product:

Portwest Style G476 Glowtex Hi Vest, the garment is constructed from a 124g/m² warp knitted polyester fabric in Yellow. The garment features one band of retroreflective tape sewn on encircling the torso with over the shoulder bands. Additionally a 5cm band of photo luminescent material is sewn on at the chest and back, and a 4.5 cm band of photo luminescent material is sewn on immediately above the horizontal retroreflective band. The garment has a mobile phone pocket and pen on the right breast and two lower bellow pockets with flaps. The garment is available in ten nominal sizes the smallest being S.

When examined the PPE satisfied the relevant requirements in the harmonized standards,





